All bids must be in writing and delivered by hand, Fed Ex, or mail to Muddy Creek Township, 911 D Perry Highway, Post Office Box 239, Portersville, Pa 16501; and must be received by 1:00 PM, Prevailing Time, March 17, 2010. Bids will be open and read aloud on March 17, 2010 at approximately 7:15 PM at the Board of Supervisor's. Bid received after the time set for receiving bids will be rejected and returned unopened to the bidder. All interested parties are invited to attend.

Each bid shall be submitted on the bid form provided. Bids are to be sealed and plainly labeled "**BID – SINGLE BITUMINOUS SEAL COAT.**"
